

Brookland School Board Meeting  
September 11, 2014

The regular meeting of the Brookland School Board was held on September 11, 2014 in the board room of Brookland Public Schools.

The meeting was called to order at 7:00 p.m. by President Lynn Price.

Motion by Josh Gallion and second by Wayne Still to approve the previous minutes from the August 18, 2014 meeting, passed 7-0.
